#### **Lessons Learned from Unexpected Procurement Problems**



Liz Busch has more than 23 years experience in Canadian public sector procurement, most of which as an employee of the Province of British Columbia. She left government to start her own consulting practice in 2019, where she now assists both public sector entities and vendors with their procurement projects and training needs.

Liz has considerable experience in managing Canadian procurement solicitations and has been a major participant in many innovative procurement changes within the Province of BC, including the <a href="Procurement Community of the Community of t

Practice and the Procurement Concierge Program.

Liz has experience developing and updating procurement policy and solicitation templates and has written considerable guidance for both vendors and public sector staff on procurement, some of which can be found on LinkedIn.

Liz is also an accomplished facilitator and speaker, having developed and delivered many procurement workshops and presentations for public sector buyers and vendors.

Through small group work and class discussion, attendees will explore how procurement decisions and unforeseen events can put an owner in a difficult position of deciding between equally risky options. Focusing mostly on the solicitation process, the workshop will explore how these situations can occur and will delve into what the Canadian Courts decided in similar cases. Attendees will come away with appreciating the nuances of procurement decisions, and with new ideas for proactively avoiding getting into these situations themselves.

- Relying on professional consultants' procurement advice
- Shifting dates when "time is of the essence"
- Bias when an incumbent contractor bids
- Tempting out-of-scope offers
- Impacts of intellectual property rights

#### **Opening Keynote Speaker**

#### **Georgette Reed**



Georgette Reed has had a keen interest in Sport, Fitness, Health, and Wellness all of her life. A certified track and field and strength and conditioning, coach with 47 years of competitive experience under her belt in the sports of athletics, bobsleigh, swimming and water polo, Georgette now puts all of the knowledge and expertise to good use as the Director of Athletics and Recreation at Capilano University. Before coming to Cap, Georgette was the Health and Wellness Coordinator for Edmonton Fire Rescue Services and Mental Health First Aid, Psychological First Aid and R2MR (first responder) instructor and master trainer for the City of Edmonton for over 10 years.

During her athletic career, Georgette represented Canada in the Olympic Games, the World Athletics Championships, The World Bobsleigh Championships, The Pan American Games, The Commonwealth Games, and many other international events. As a competitor, Georgette won 17 national titles (15 in the shot put and two discus titles). Upon retiring from competing, Georgette was the Head Cross Country, Track and Field coach for the Univ. of Alberta for 10 years, and helped develop champions at the provincial, national and international levels and was a mentor/coach for Special Olympics Athletics athletes and coaches in Alberta.

Currently, Georgette competes as a masters' athlete in the throwing events and volunteers coaching Olympic and Paralympic hopefuls in the throwing events and is a mentor coach for Athletics Canada helping guide future high-performance coaches.

Kim has interacted and collaborated with hundreds of organizations while stewarding dozens of connections between corporations and communities to identify opportunities for sustainable procurement and community benefit. This work has been recognized around the globe.

Previously, Jonathon worked at MNP as a Senior Manager in Indigenous Services, delivering organizational management, policy development, strategic planning, financial administration, community reporting, budgeting, and economic

and business development, while encouraging sustainable initiatives.

Jonathon is always looking for meaningful and sustainable ways to position Indigenous peoples and communities for prosperity and growth. Jonathon works closely with Indigenous organizations, communities, and peoples to provide leadership, mentorship, and financial governance to promote Indigenous sovereignty and the overall development of Indigenous Peoples.

Jonathon is currently a Board of Director at Supply Chain Canada, BC – an organization that ensures Canadian supply chain professionals and organizations are recognized for leading innovation, global competitiveness, and driving economic growth. Judy Kitts has 15 years of experience in Indigenous relations. She started her career working with Indian Residential Schools Resolution Canada processing residential school attendance records to support the federal government's reconciliation efforts. In 2009, Judy joined the Ministry of Indigenous Relations and Reconciliation. During her time there, she led the development of the land offer in the Kitsumkalum and Kitselas First Nations' Incremental Treaty Agreement. She also worked on the Tsawwassen First Nation's Final Agreement and the Tsleil-Waututh Nation's Agreement in Principle. In 2011, Judy joined the Port of Vancouver as the organization's first full-time dedicated position in Indigenous relations. Judy lead the development and implementation of the Port's Indigenous consultation process, creating critical policies and guidelines to support meaningful consultation. Judy currently works for the Greater Victoria Harbour Authority (GVHA) as their

First Nations Engagement Manger in a part-time position. She works closely with the Esquimalt Nation and Songhees Nation on development projects, employment initiatives, and procurement opportunities. Judy also

supports other like-minded organizations through her consulting firm, Kitts Consulting. In this capacity, she currently supports the Victoria Airport Authority as they work to enhance their relationship with the WSÁNEĆ Nations as well as other clients, including the Capital Regional District and the Greater Victoria Chamber of Commerce.

#### **Closing Keynote Speaker**

#### Dr. Andrew Weaver



Dr. Andrew Weaver is one of the world's foremost climate scientists and a leading expert on global warming. Through his work, Weaver has reenergized a new generation of discussions on climate change and sustainability, setting off what David Suzuki calls "the final alarm that galvanizes us to move onto a different energy path of renewables and efficiency." Straight-forward, frank, and engaging, Weaver's talks breathe urgent life into some of the most important issues of our lifetime.

Weaver was a lead author in the second, third, forth, and fifth Assessment Reports with the UN Intergovernmental Panel on Climate Change—the group that, with Al Gore, won the 2007 Nobel Peace Prize—and is a Lansdowne Professor at the University of Victoria.

He is the author of the books, *Keeping Our Cool* and *Generation Us*; has authored or co-authored over two hundred peer-reviewed studies in climate, earth science, policy, and education journals; and was chief editor of the *Journal of Climate* from 2005-2009.

A recipient of numerous awards, Weaver was named a Guggenheim Fellow; a Fellow of the American Meteorological Society; a Fellow of the American Geophysical Union; a Fellow of the American Association for the Advancement of Science; a Fellow of the Canadian Meteorological and Oceanographic Society; a Fellow of the Royal Society of Canada; and a Member of the Order of British Columbia.
