Reporting to the Chief Financial Officer the primary responsibilities of this role include:

- Developing, overseeing and providing supervision for the procurement function on behalf of the CVRD
- Managing capital and providing strategic advice on complex procurement, and best value procurement practices
- Planning and leading the request for proposals/quotations/ and other necessary information in order to make decisions on the best method of completing the acquisition of goods and services
- Preparing and conducting board and public presentations with respect to the CVRD's procurement processes when required
- Maintaining and enhancing the vendor performance program and reporting on performance objectives in accordance with contractual terms and conditions
- Continuing to research emerging best practices for procurement and negotiation
- Engaging with external associations and organizations related to the procurement process within the public sector
- Supporting internal departments by way of building internal capacity through training and overseeing procurement activities
- Providing training, guidance, performance evaluations, coaching, and career development to procurement support staff.
