This position is located at Pretium's Brucejack site within the Supply Chain department. The position's primary report is to the Warehouse Operations Superintendent.

About the Opportunity:

We currently have an exciting opportunity available for a Supply Chain Manager to join the Brucejack Mine in Northwestern, British Columbia.

In this role, you will be responsible for overseeing and directing all procurement, purchasing, distribution and financial forecasting of equipment, materials and supplies to and from the Brucejack Mine. This includes responsibility for coordinating shipping/receiving, inventory control and tracking of goods to ensure the most cost-effective availability of parts and material for the seamless operation of the project in a safe and effective manner while overseeing supply chain personnel. Position will be located in Smithers, British Columbia.

The position report is to the General Manager or designate.

Responsibilities:

Perform the following duties, with safety being the number one priority:

- Examine existing procedures or opportunities for streamlining activities to meet product distribution needs.
- Review or update supply chain practices in accordance with environmental policies, standards and regulations.
- Lead the supply chain team in executing best practices and measuring performance through agreed upon Key Performance Indicators (KPIs) such as on time delivery, on time shipping, fill rate, and customer/carrier scorecards.
- Collect, audit, analyze and report monthly KPIs to senior management.
- Select transportation routes to maximize economy by combining shipments or consolidating warehousing and distribution.
- Diagram supply chain models to help facilitate discussions with customers.
- Develop material costs forecasts or standard cost lists.
- Assess appropriate material handling equipment needs and staffing levels to load, unload, move, or store materials.
- Negotiate prices and terms with suppliers, vendors, or freight forwarders.
- Monitor supplier performance to assess ability to meet quality and delivery requirements.

- Monitor forecasts and quotas to identify changes or to determine their effect on supply chain activities.
- Consult with suppliers to discuss supply/delivery issues or to discuss material/supply forecasts or changes.
- Implement new or improved supply chain processes.
- Collaborate with other mining departments to identify or qualify new suppliers.
- Develop or implement procedures or systems to evaluate or select suppliers.
- Analyze information about supplier performance or procurement program success.
- Design or implement supply chains that support environmental policies.
- Document physical supply chain processes, such as workflows, cycle times, position responsibilities, or system flows.
- Design or implement warehousing strategies for equipment, materials and supplies.
- Direct and confer with Supply Chain Departmental staff (Buyers/Logistics Coordinators/Shipping/Receiving) to forecast demand or create supply plans that ensure availability of materials or products.
- Monitor, evaluate and address supply chain employee performance.
- Providing supply chain members with essential market and product information to assist them in planning their own work schedules.
- Define performance standards for measurement, comparison, or evaluation of supply chain factors, such as product cost or quality.
- Manage activities related to strategic or tactical purchasing, material requirements planning, inventory control, warehousing, or shipping/receiving.
- Develop procedures for coordination of supply chain management with other mining departments.
- Design or implement supply chains that support business strategies adapted to changing market conditions, new business opportunities, or cost reduction strategies.
- Conduct or oversee the conduct of life cycle analyses to determine the environmental impacts of products, processes, or systems.
- Design, implement, or oversee product returns to ensure products are recycled, reused, or responsibly disposed.
- Evaluate and select information or other technology solutions to improve tracking and reporting of materials or products distribution, storage, or inventory.
- Identify opportunities to reuse or recycle materials to minimize consumption of new materials, minimize waste, or to convert wastes to by-products.

Qualifications:

• A bachelor's degree/diploma in business, finance or certification from a recognized and accredited purchasing management association (ie. SCMP)

- Ten to fifteen years direct progressively responsible experience in an industrial purchasing environment to include 5 years demonstrated and proven staff supervision.
