And is required to analyze procurement activities on a Department, Faculty and University basis to determine and develop appropriate methods of facilitating acquisitions.

To be considered for this opportunity, you will bring the following:

Certified Supply Chain Management Professional (SCMP) designation or completed Certificate in Purchasing or equivalent required including successful completion of post-secondary courses related to contract and competitive bidding law, and contract development and negotiation. Minimum of three (3) years of procurement experience in a public sector environment. Knowledge of other educational/public sector organization's purchasing policies when participating in cooperative buying groups. Knowledge of any major changes/developments in commodities (e.g. introduction of new product lines), knowledge of research related acquisitions would be an asset. With any new products, the total cost of ownership must be analyzed (i.e. product life cycle, warranty costs). Knowledge of Competition Act, Sale of Goods Act, Canada and European Comprehensive Economic and Trade Agreement, Canadian Free Trade Agreement, and, Ontario-Quebec Procurement Agreement. Overall understanding of public policy that underlies public principles including requirement to operate in fair and transparent manner. Experience interpreting directives, guidelines, legislation and regulations in the public sector. Obligations surrounding fiduciary responsibility for public funds. Experience in sustainability would be an asset.
