- Perform as core member of the Program Integrated Product Team for NPI programs in Honeywell Cambridge and Ottawa.
- Execute the established management operating system (MOS), driving program performance and supplier accountability, including delivery and quality performance and program schedule fidelity.
- Direct both HON and supplier organizations, and coordinating with the business, to develop root cause and corrective actions associated with supply chain delays, quality escapes, design defects, and resource management to assure on time customer delivery.
- Drive on site supplier interactions and engagement as required.
- Frequent contact with Marketing & Product Management (M&PM), ISC Engineering (AME), Program Management, Engineering and Operations regarding program(s) status, problems and performance.
- Support supplier and customer visits at various levels during audits, new business opportunities, and problem resolutions. Own the external relationships with key suppliers.
- Purchase goods, materials and services for NPI Development programs ensuring that company and Canadian Government and commercial operational needs are met.
- Key deliverable's include fair and reasonable price, quality, delivery and continuity of supply, long term contracting, and subcontracting activities on all NPI Sourcing and Procurement scope of work for Honeywell Cambridge and Ottawa.
- Execute purchasing activities will include negotiation of mid to large-size purchase orders, complex purchase order documentation, meeting internal objectives while achieving overall cost effectiveness.
- Directly interact with your internal stakeholders and with external vendors specific to NPI program goals and objectives.
