- Support the quoting process by collaborating with our quoting team to source appropriate materials.
- Identify cost reduction opportunities, send RFQs, review quotations, invite tenders, negotiate discounts, volume pricing, and favorable terms.
- Develop and maintain relationships with existing and potential vendors; perform analysis of performance following our vendor approval process.
- Review inventory at regular intervals; adapt and optimize purchasing volumes and inventory levels to changing project needs and customer demand patterns.
- Complete purchase orders as per AS9100 requirements and PCI internal processes, ensuring quality requirements are understood and passed to vendors.
- Track status of orders and resolve issues as required; evaluate supply risks and address unforeseen disruptions in the supply chain.
- Work with quality department to discuss defective or unacceptable goods and determine disposition or corrective action required.
- Lead improvements in purchasing, inventory and logistics processes.
